- Facilitate & accelerate connections with running initiatives (good projects where providers or healthcare system players can look at the state of the art of specific technology domains)





OUR ACTION PLAN UNTIL DEC. 2021

- **Network coordination:** 4 online meetings
- 1 or 2 **thematic webinars** which may be opened to interested stakeholders which could act as a "public showroom" for our initiative and where we may focus on a specific topic and give the floor to those DIHs that have relevant experiences / use cases. The ideal scenario includes an on-site meeting at **Medica** in November 2021
- **Design 1 or 2 common projects (HEurope / WP Health)** which may involve at least 3-4 of our network members each
- Establish 4 DIH Corridors
- Formally **connect to the institutional EU platforms** that are focusing on digital health and complementary topics (Active and Healthy Ageing, etc.)
- Finalize a **Business Plan** for 2022-2023 and attract resources to manage the network in a sustainable way
- Identify the most **suitable legal structure** to be adopted by the network
